# CM awards 5 cops for outstanding work in eradicating drug menace

Chennai, Aug 13: As part of the Drug-Free Tamil Nadu initiative, Chief Minister MK Stalin presented the Chief Minister's Medal 2024 to five police officers for their exemplary efforts in combating drug-related issues. The awards ceremony took place on Monday at Madras University.



The honored officers were R Shiva Prasad, SP of Theni district; P Jaganathan, Inspector in Salem; K Rajkumar, Inspector in Chennai; R Arun, SSI from

Othakadai Traffic; and R Durai, Head Constable in Ramanathapuram. During the event, Chief Minister Stalin, alongside students and police

personnel, took a pledge to work towards a drug-free Tamil Nadu.

According to a press release, by June this year, authorities had

registered 4,522 drug-related cases and arrested 7,123 individuals. During this period, approximately 11,000 kg of ganja, 74,000 drug tablets, and 283 kg of other banned substances were seized.

On Monday alone, the police destroyed around 13,775 kg of drugs across Tirunelveli, Thanjavur, Chengalpattu, and Salem districts. The event was attended by Minister K Ponnudi, MP Dayandhi Maran, Chief Secretary Shiv Das Meena, Additional Chief Secretary Dheeraj Kumar, DGP Shankar Jiwal, Additional DGP Davidson Devasirvatham, Police Commissioner A Arun, and Additional DGP A Amalraj.

# Apollo Hospitals performs dual heart valve repair, new hope for high-risk heart patients

Chennai, Aug 13: Apollo Hospital Chennai has performed India's first successful Mitral and Tricuspid Transcatheter Edge-to-Edge Repair (TEER) on a 59-year-old woman with severe heart failure. This significant achievement offers new hope to high-risk heart failure patients in India, showcasing TEER as a viable alternative to traditional surgery.

The patient had previously undergone a heart procedure in 2021 in Thirunelveli. Despite initial success, she developed severe symptoms, including difficulty breathing and leg swelling, due to issues with two of

her heart valves. These complications made managing her heart failure profusely challenging.

Upon her admission to Apollo Hospitals, doctors found that her heart was not pumping effectively and that both her mitral and tricuspid valves were leaking. Despite receiving medications and supportive care, her condition did not improve, prompting the medical team to consider a more advanced treatment option.

Dr. Sai Satish, Senior Consultant in Interventional Cardiology at Apollo Hospitals Chennai, led the team in choosing the TEER procedure. This minimally invasive approach was

selected because traditional surgery posed too high a risk. After discussing the procedure's risks and benefits with the patient and her family, they proceeded with TEER, simultaneously for both the valves.

Dr. Sai Satish, Clinical Lead Transcatheter Heart Valve Therapies for Apollo Group remarked, "This innovative procedure highlights the exceptional synergy of medical advancement, Apollo's state-of-the-art capabilities, and the expertise of our dedicated doctors. The dual valve repair, a first in India, reflects our team's ability to handle complex cases and

improve patient outcomes. The patient's smooth recovery and symptom relief demonstrate the effectiveness of our approach, offering new options for those with challenging heart conditions."

TEER, or Transcatheter Edge-to-Edge Repair, is a modern, minimally invasive technique used to treat conditions like mitral regurgitation, where the heart's mitral valve does not close properly, causing blood to leak backward. The procedure involves threading a catheter with a small clip to the valve to help it close more fully, improving blood flow and reducing symptoms.
