## AIADMK confident of sweeping over 200 seats, claim former Ministers

Tiruppur, Nov. 15: Former Ministers Udumalai K. Radhakrishnan and M.S.M. Anandan, district functionaries K.R. Arjunan and Vignesh participated in a meeting on the special voter revision work held by the Tiruppur Corporation's Veerapandi area on behalf of the AIADMK in the Palladam constituency. As announced by the Election Commission of India, a consultation and training session for Booth Level Agents (PLA-2) regarding the special voter revision for the Tiruppur Corporation areas of Veerapandi (West and East) under the Palladam Assembly constituency was conducted at the Vaaniba Chettiar Marriage

Hall in Kupbandampalayam. Area secretaries Surendar, Pannaiyar Palanisamy and others presided. Addressing the gathering, district secretary Udumalai K. Radhakrishnan and M.S.M. ## TN Govt. offers financial assistance to Jerusalem Pilgrims, applications open

Coimbatore, Nov. 15: The Tamil Nadu Government has announced that applications are now being accepted for providing financial assistance to Christians who undertook the Jerusalem Holy Pilgrimage after November 1. As part of the subsidy scheme benefiting 600 Christians across Tamil Nadu, pilgrims who have returned from Jerusalem will receive financial support directly through the ECS system. A subsidy of Rs. 37,000 per person will be given to 550 Christian pilgrims,

while 50 nuns/sisters will receive Rs. 60,000 per person.
